NBCC to cover tuition for former youth in care

April 06, 2021 (Fredericton, NB) – New Brunswick Community College (NBCC) has become the first post-secondary institution in New Brunswick to eliminate tuition barriers for those who have spent a year or more in foster or group home care.

The Former Youth In Care Tuition Bursary covers all tuition and program fees for <u>eligible</u> <u>applicants</u>, regardless of age, beginning in September, 2021.

"Quality education and skills training are crucial to obtaining sustainable employment, yet the cost of education can be a barrier to those who most need it," said Ann Drennan, Vice President Academic and Research at NBCC. "Removing that barrier for former youth in care levels the playing field so those learners are not left behind."

NBCC has partnered on this initiative with the Child Welfare Political Action Committee, a federally-incorporated, not-for-profit organization that advocates for a progressive child welfare system. To-date, the Child Welfare Political Action Committee has helped create more than 150 tuition-free opportunities at 13 schools in five provinces.

"As a former youth in-care, I am grateful that the opportunity to study at NBCC will be there when students are ready," said Jane Kovarikova, founder of the Child Welfare Political Action Committee and current doctoral candidate at Western University. "One day in Canada, it won't matter where you were raised in care, thanks to the leadership of organizations like NBCC that care about your future."

- This work was inspired by the <u>Vancouver Island University tuition waiver program</u> (no age limits) for people who were raised in care in B.C.

Child rights advocate, Jane Kovarikova, grew up in foster care since the age of six and began living on her own at age 16. She graduated with a BA (Hon) in Psychology at Laurentian University and a MSc in Human Rights from the London School of Economics. As a political staffer at the Ontario Legislative Assembly, she was instrumental in developing legislation that is reducing youth homelessness today. Influenced by these earlier experiences, Kovarikova founded the Child Welfare PAC Canada in 2017. This not-for-profit focuses on systemic changes that support youth success after being raised in state care. Currently, Kovarikova serves as the Board Chair of Simcoe-Muskoka Family Connexions, a regional child protection agency, and on the Ontario Premier's Council for Equality of Opportunity. She is also a PhD Candidate and Lecturer at Western University in the Department of Political Science.
